ORDER:

- The RTI application is dated 14.09.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 28.09.2022 and the second appeal was filed in the Commission on 31.10.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
- 2. The notice of hearing was issued to the parties for 04.01.2023. Accordingly, the case has been heard today. Shri Himanshu Singla, appellant comes present to attend the hearing in person before the Bench and states that he has not received any information.
- Shri Rajvir Singh, Senior Assistant O/o District Sports Officer, Sangrur comes present in 3. person before the Bench to attend the hearing on behalf of the PIO and states that point-wise reply has been given to the appellant vide letter dated 21.09.2022 by e.mail and then by registered post on 31.10.2022.
- 4. On the asking of the Bench, the appellant expresses dis-satisfaction on certain points. After perusing the RTI application, the Bench observes that the appellant has put certain questions which cannot be construed as the information, rather the same reveal the grievance of the appellant with regard to the usage of Multipurpose Indoor Sports Hall by general public. The respondent states that it has mainly been constructed for the use of upcoming players preparing for the competitions and it is not a recreational complex for use by general public.
