ORDER:

- 1. The RTI application is dated 21.07.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 24.08.2022 and the second appeal was filed in the Commission on 31.10.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
- 2. The notice of hearing was issued to the parties for 11.01.2023. Accordingly, the case has been heard today. Shri Gagandeep Singh Threeke, appellant comes present to attend the hearing through cisco webex.
- 3. Shri Rajiv Saggar, Superintendent and Shri Navdeep Sharma, Vigilance Officer O/o Chief Vigilance Officer, Local Govt., Punjab come present in person before the Bench to attend the hearing on behalf of the PIO. Shri Rajiv Saggar states that information has been supplied to the appellant vide letter dated 09.01.2023. He further states that as per report received from the Improvement Trust, Ludhiana, action on point no.1,4,5,6 & 7 has been finalized and closed whereas enquiry on point No.2 & 3 is still in progress and as such, this cannot be supplied under Section 8(1)(h) of RTI Act.

4. The appellant is apprised of the version of the respondent. On the asking of the Bench,

the respondent explains to the appellant the position regarding the information supplied. The appellant

expresses dis-satisfaction over the information supplied and states that on points in which enquiry has

the complaints have been dealt with on a single file and thus, copies can be provided only after all the

action on balance of two complaints is finalised.

advised to come present in person before the Bench on the next hearing.
