It is further clarified that information relating to point number 2 and 3 has been with held as enquiry is under process. It be further stated that nothing has been concealed therein and the statement made is true and correct. The original affidavit be sent to the appellant and copy of the same be sent to the Commission for record.

7. With the aforesaid directions, **the instant appeal case is disposed off and closed**. Copies of the order be sent to the concerned parties.
