ORDER:

1. This order may be read with reference to the order dated 01.03.2023 passed by this Bench on the previous hearing.
2. The case has been heard today. As per respondent, in compliance with the order of the Commission, point-wise reply/information has been sent to the appellant vide letter dated 17.03.2023 with a copy to the Commission through email.
3. The appellant is absent nor is represented and has not communicated any discrepancies.
4. Having gone through the RTI application and the reply of the PIO, the Commission observes that the information on point-1 stands provided. The information on point 2 & 3 relates to Director of Factories, Pb and the appellant has been asked by the PIO to make further correspondence with the concerned department. However, the PIO has not transferred the RTI application to the concerned department under section 6(3) of the RTI Act. The PIO is directed to transfer the RTI application to the PIO-Director of Factories, Pb under section 6(3) of the RTI Act and the PIO-Director of Factories, Pb is directed to provide information relating to point 2 & 3 to the appellant once the RTI application is received from the office of GMADA.
5. Since the appellant is absent on 2nd consecutive hearings nor is represented to pursue his case, the appellant is directed to make further correspondence with the PIO-Director of Factories, Pb O/o Chief Town Planner, Patiala for information relating to point 2 & 3. A copy of reply received from the PIO is sent to the appellant along with the order.
6. With the above observation and order, the case is **disposed off and closed**. Copies of order be sent to the concerned parties.
