**ORDER:**

1. The RTI application is dated 19.07.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 02.09.2022 and the second appeal was filed in the Commission on 01.11.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 04.01.2023. Accordingly, the case has been heard today. Shri Paramjit Singh, appellant has not come present to attend the hearing in person before the Bench or through cisco webex.
3. Neither the PIO O/o ADC (Development), Fazilka has come present in person before the Bench nor through cisco webex. However, a letter dated 03.01.2023 has been received by e.mail from the PIO stating that the information has already been supplied vide letter dated 03.10.2022. After the filing of present appeal case by him, he was called to office on 02.01.2023 and complete information has been supplied to him to his satisfaction and the appellant has also given in writing to this effect. The PIO has further sought exemption from personal appearing in the hearing on 04.01.2023.
4. On perusal of the case file, the Bench finds that the appellant has also given acknowledgement for having received information to his satisfaction on 02.01.2023 and has also given his consent to dispose off the instant appeal case.
5. In view of the above, no further cause of action is left in the matter. **The instant appeal case is disposed off and closed.** Copies of the order be sent to the concerned parties.
