ORDER:

1. The RTI application is dated 01.08.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 05.09.2022 and the second appeal was filed in the Commission on 03.11.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. The notice of hearing was issued to the parties for 11.01.2023. Accordingly, the case has been heard today. Shri Gagandeep Singh Threke, appellant comes present to attend the hearing through cisco webex. He states that no information has been received by him so far nor the order of First Appellate Authority to provide information has been complied with.

3. Shri Bhupinder Singh, Senior Assistant O/o GLADA, Ludhiana comes present to attend the hearing on behalf of the PIO through cisco webex. He states that reply has been given to the appellant vide letter dated 06.01.2023 stating that the site of colonies mentioned in the RTI was checked and a colony of about 23 acres was seen being developed which is a licensed colony by the name of Solitaire Homes and there is another colony Sai Enclave Colony against whom FIR has been got registered.

4. The appellant is apprised of the version of the respondent. He denies the receipt of any information and also expresses dis-satisfaction over the version of the respondent.
