## **ORDER:**

- 1. The RTI application is dated 01.08.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 05.09.2022 and the second appeal was filed in the Commission on 03.11.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

- 4. The appellant is apprised of the version of the respondent. He denies the receipt of any information and also expresses dis-satisfaction over the version of the respondent.
