**ORDER:**

1. The RTI application dated 17.09.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 19.11.2022 and second appeal was filed in the Commission on 10.01.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for hearing for 05.07.2023 at 11.00 a.m. through CISCO WEBEX application.
2. In today's hearing, respondent, Sh. Sanjay Kumar states that the information has been sent to the appellant on 21.03.2023 and no discrepancy has been received from the appellant till date. He adds that a copy of the same was also sent to the Commission vide letter no. 927 dated 21.03.2023, which is received vide diary no. 7614 dated 22.03.2023 and taken on record. He also mentioned that an email dated 03.07.2023 is also sent to the undersigned Bench in this regard. This email is received and taken on record.
3. Appellant is absent in spite of registered post notice issued to him by the Commission.
4. After examining the case file, it is observed that no communication is received from the appellant after filing case in the Commission/after issuing him notice of hearing, which means he has nothing to say in this regard. Due to non-serious attitude of appellant, there is no purpose to keep this case pending, which is a sheer wastage of precious time and resources of the Commission, is not acceptable at all. Therefore, this instant appeal case is **disposed of & closed**. Copy of the order be sent to the parties.
