**ORDER:**

1. The RTI application is dated 15.12.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 23.1.2023. The second appeal was filed in the Commission on 14.3.2023 Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and the hearing was fixed for 27.7.2023 at 11.00 a.m., which was preponed to 24.7.2023 at the office of PSIC at Chandigarh.
2. In today's hearing both the parties are present.
3. The appellant states that sufficient time has elapsed but the sought for information is still awaited. He further pleads that suitable direction be given to the respondent so that he may get the information. He further adds that similar information he got from RTA, Hoshiarpur & Amritsar which is with regard to insurance of the vehicles.
4. The respondent states that the information sought for is purely 3<sup>rd</sup> party information which is exempted in the RTI Act.
5. After hearing both the parties and examining the case file, it is observed that appellant is not satisfied with the supplied information/reply. Accordingly, respondent PIO is directed to go through the official record once again and supply the information, in case information cannot be supplied, supply an affidavit in original duly attested by the respondent PIO as per RTI application to the appellant within ten days under intimation to the Commission.
6. Both the parties are advised to represent this case in person on the next date of hearing, failing to which, appropriate order in their absence shall be passed.
7. With the aforesaid directions, the matter is adjourned. To come up for hearing on **04.09.2023 at 11.00 AM before the Bench in Commission's office at Chandigarh**. Copies of the orders be sent to the concerned parties.
