## ORDER:

The appellant, through an RTI application dated 04.09.2021( online) & 04.10.2021 by registered post, has sought information regarding the copy of the action taken report on grievance No.PESIC/E/2021/01244 dated 09.06.2021 and PESIC/E/2021/01516 dated 12.07.2021 by Baljit Singh – a copy of the complaint regarding the non-functioning of the x-ray machine in ESI Hospital – complaint dated 03.09.2021 made to Medical and other information as enumerated in the RTI application concerning the office of the Director, Health & Family Welfare, Punjab, Chandigarh. The appellant was not provided with the information after which the appellant filed the first appeal before the first appellate authority on 08.10.2021 which took no decision on the appeal.

The case last came up for hearing on 25.08.2022 through video conferencing at DAC Amritsar. As per the appellant, the PIO had not supplied the information.

The respondent was absent.

The PIO-ESI Hospital Amritsar vide letter dated 03.08.2022 received in the Commission on 13.08.2022 as well as a copy through email informed that they received the RTI application of the appellant from the office of DHS, Pb Chandigarh on 22.10.2021 and the information was sent to the appellant vide letter dated 11.11.2021, with a copy of the information alongwith the letter dated 03.08.2022 to the Commission.

A copy of the information received from the office of ESI Hospital Amritsar was sent to the appellant alongwith the order, and the appellant was directed to point out the discrepancies if any in the provided information to the PIO and the PIO was directed to sort out the same.

## Hearing dated 22.11.2022:

The case has come up for hearing today through video conferencing at DAC Amritsar. As per the respondent, the complete information has already been provided to the appellant and no further information is available in the record.

The appellant is absent nor represented as well as not communicated any discrepancies. It is presumed that the appellant has received the information and is satisfied.

Since the information has been provided, no further course of action is required. The case is **disposed of and closed.**
