## <u>ORDER</u>

- This order may be read with the reference to the previous order dated 17.10.2022.
- 2. The case has been heard today in the Commission's office at Chandigarh. Shri Amarjit Singh, Superintendent states that the information has been supplied to the Appellant vide letter dated 09.11.2022 and again on15.11.2022.
- 3. Shri Jasbir Singh, appellant is absent and telephonically message has been given by the appellant to the Bench that he has received the information and further requests to close this case.
- 4. Post deliberations and after going through the documents placed on record, the Bench observes that a penalty of Rs. 5000/- (Rupees Five Thousand Only) was imposed upon PIO O/o Chief Administrator, GLADA, Ludhiana vide order dated 11.07.2022 and has not been deposited in the Government Treasury.
- 5. PIO O/o Chief Administrator, GLADA, Ludhiana is directed to look into this matter and ensure that penalty amount Rs. 5000/- is deposited in the Government Treasury. The PIO is further directed to send the copy of challan as evidence to the Bench after depositing the penalty in the Government Treasury and also directed to submit the reply to show cause notice to the Bench.
- 6. As the Appellant is satisfied with the supplied information. In view of above, the case file be sent to the Deputy Registrar, PSIC to ensure compliance of the directions of the Bench relating to reply to show cause notice and deposition of penalty amount of Rs. 5000/- in the Government Treasury, as directed by the Bench.
- 7. With the aforesaid directions, **the instant case is disposed off and closed.** Copies of the order be sent to the concerned parties.
