ORDER:

1. This order may be read with reference to the order dated 16.01.2023 passed by this Bench on the previous hearing.
2. The case has been heard today. Shri Gurmej Lal comes present through cisco webex to attend the hearing on behalf of Shri Amarjit Singh Dhamotia, appellant. He states that the appellant has not been provided any information till date.
3. Neither the PIO O/o Director, Local Government, Punjab, Chandigarh has come present to attend the hearing on behalf of the PIO in person before the Bench or through cisco webex. However, a letter dated 17.01.2023 received by e.mail is available in the case file, the perusal of which shows that the appellant has been given point wise reply, stating that action on the complaint of appellant dated 19.07.2022 & 16.07.2022 is to be taken by the O/o Commissioner, Municipal Corporation (Zone-C), Ludhiana, from whom no report has been received by the office of Director, Local Government, Punjab till date.

The Bench observes that the PIO has sent point wise reply to the appellant and on perusal of the reply, it is clear that requisite action on the complaints made by the appellant has to be taken by the PIO O/o Commissioner, Municipal Corporation (Zone-C), Ludhiana. Copy of letter dated 17.01.2023 be sent to the appellant along with the order and the appellant is advised to contact the officer concerned in Municipal Corporation (Zone-C), Ludhiana.

5. With the aforesaid directions, the Bench does not feel need further intervention in the matter. **As such, the instant appeal case is disposed off and closed.** Copies of the order be sent to the concerned parties.
