**ORDER:**

1. This order may be read with reference to the order dated 16.01.2023 passed by this Bench on the previous hearing.
2. The case has been heard today. Shri Gurmej Lal comes present through cisco webex to attend the hearing on behalf of Shri Amarjit Singh Dhamotia, appellant. He states that the appellant has not been provided any information till date.
3. Shri Navdeep Sharma, Vigilance Officer, Vigilance Cell, O/o Director, Local Govt., Punjab, Chandigarh comes present in person before the Bench to attend the hearing on behalf of the PIO and states that the appellant has sought enquiry report into the works got executed by B&R Branch of Zone C, Municipal Corporation, Ludhiana. He further states that as per orders of Director, Local Govt., the Commissioner, Municipal Corporation, Ludhiana has been directed vide letter dated 03.08.2022 to get the enquiry conducted through a technical officer and to send report thereon. However, no report has been received in this regard yet.
4. On the asking of the Bench, the respondent also explains the position regarding the enquiry into the complaints made by the appellant to the representative of appellant. The representative of the appellant, however, denies receipt of any information from the PIO. As such, the Bench directs the respondent to send the same to the appellant on his WhatsApp number as also by e.mail today itself, who assures the Bench to do the needful. The appellant is also advised to contact the officer concerned in Municipal Corporation, Ludhiana.
