**ORDER:**

1. The RTI application is dated 18.10.2021 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 13.12.2021 and the second appeal was filed in the Commission on 09.11.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. The notice of hearing was issued to the parties for 12.01.2023. Accordingly, the case has been heard today. Shri Suresh Kumar, appellant comes present in person to attend the hearing. He states that no information has been received by him so far.

3. Shri Raminder Pal Singh, XEN- cum – APIO who comes much after the hearing of cases for the day is over and states that the appellant was called to their office yesterday and the record had been identified by him personally. He further assures that the attested copies of identified record will be sent to the appellant by the next date of hearing.

4. Post deliberations, the PIO O/o Improvement Trust, Amritsar is directed to send the attested copies of identified record to the appellant through registered post along with a the copy of the same to the Bench through email by the next hearing.

5. Both the parties are directed to ensure their presence in person before the Bench on the next hearing.

6. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 16.02.2023 at 11.30 AM before the Bench in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
