ORDER:

1. The RTI application is dated 18.04.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 20.05.2022 and the second appeal was filed in the Commission on 09.11.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 12.01.2023. Accordingly, the case has been heard today. Shri Suresh Kumar, appellant comes present in person. He states that no information has been received by him so far.
3. Shri Gurpal Singh, Assistant Engineer on behalf of the PIO O/o Municipal Corporation, Amritsar states that the information as available in their official record is ready with them and it will be supplied to the appellant through registered post and email as well. The copy of covering letter number 303 dated 06.01.2023 has already been sent to the Bench through email, which is seen and taken on record.
4. The appellant is apprised of the version of the respondent. He states that the same may be directed to be given by the PIO by way of affidavit.
5. Post deliberations, the PIO O/o Municipal Corporation, Amritsar is directed to send the information to the appellant through registered post as well as through email at sharma.da.gr8@gmail.com today itself. The Bench also directs the PIO to file an affidavit on non-judicial stamp paper, within 21 days, duly signed by the PIO and attested by the Notary Public to the effect that information as available in official records has been supplied to the appellant in AC: 5422 / 2022.
