ORDER:

1. This case may be read with the reference to the previous order dated 18.04.2023.

2. In today's hearing, the appellant Sh. Bhushan Jain states that no information has been supplied to him. He further adds that he has sent a letter dated 04.05.2023 in this regard, which has been received by the Commission vide diary number 12835

dated 26.05.2023 and taken on record.

3. The respondent is absent second time without any intimation to the Commission. Commission takes a serious view of the casual approach of the Respondent / PIO and information is still pending to be supplied to the appellant, which shows PIO's casual attitude towards the directions of the Commission. The absence of the PIO is viewed seriously and it has also affected hearing and disposal of the case.

4. In view of the foregoing, <u>respondent PIO, O/o RTA, Ludhiana is directed to show</u>
<u>cause</u> in writing or through affidavit under Section 20(1) of the RTI Act, as to why

penalty be not imposed upon him for willful delay/ denial of the information to the

RTI applicant and why the compensation be not awarded to the complainant under

Section 19 (8)(b) of the Act for detriment suffered.

In addition to his submission, the PIO is also hereby given an opportunity under Section 20(1) proviso, thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. He may note that in case he does not file his submission and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex-parte.

- 3. On hearing held on 18.04.2023, respondent PIO was directed to supply the information within ten days after receipt of order but no response. Accordingly he is directed to deal this case on priority basis and supply the point-wise requisite information to the appellant within seven days after receipt of this order.
- 4. Appellant is also advised to point out deficiencies within 7 days from the receipt of information, failing which the case shall be decided on merits.
- 5. With the aforesaid directions, the matter is adjourned for further hearing on 09.08.2023 at 11:00 A.M. through CISCO-Webex (Video Conferencing application). Copy of the order be sent to the parties.
