**ORDER**

1. This order may be read with the reference of the order dated 03.11.2022 passed by this Bench on the previous hearing..
2. The case has been heard today. The appellant Shri Amarjit Singh Dhamotia has not come present in person before the Bench or through cisco webex. However, Shri Gurmej Lal through a telephonic message informed that as the appellant has to attend a court case in civil court, he may not be able to attend the hearing.
3. Inspector Ranbir Singh, SHO/PIO, P.S. Daba, Ludhiana comes present in person before the Bench and produces before the Bench letter dated 30.01.2023 giving point-wise replyl to the RTI Application, which is taken on record. He further states that attempts were made to contact the appellant, but he does not respond to the phone calls.
4. The Bench makes attempts to contact the appellant on his mobile phone, but he does not respond. The Bench, however, on examining the information supplied, observes that the PIO has given appropriate reply to the appellant and adequate information stands supplied to the appellant.
5. Further, in view of the submissions made by the PIO before the Bench, the show cause notice issued to the PIO is hereby dropped.
6. In view of the above, the Bench is not inclined to proceed further in the matter. The instant appeal case is disposed off and closed. Copies of the order be sent to the concerned parties. Copy of the letter dated 30.01.2023 be sent along with the order.
