**ORDER:**

1. The RTI application is dated 17.8.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 19.9.2022 and second appeal was filed in the Commission on 11.11.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. Notice of hearing was issued to the parties for hearing through CISCO WEBEX on 18.4.2023 i.e. today.
3. In today's hearing, appellant, Sh. Bhoop Ram states that information is still pending from the respondent PIO since sufficient time has elapsed.
4. Respondent, Ms. Sarabdeep Kaur states that information is sent to the appellant through registered post on 13.04.2023.
5. After hearing both the parties and examining the case file, the court advises the appellant to point deficiencies, if any, in writing, within 7 days to the respondent PIO with a copy to the Commission, failing which it will be presumed that the information supplied is sufficient and nothing to say in this regard and the case will be disposed of/closed.
6. Respondent PIO is directed to remove discrepancy if any, pointed out by the appellant within ten days after receipt letter regarding discrepancy from the appellant.
7. **Matter is adjourned for further hearing on 22.06.2023 at 11:00 A.M. through CISCO WEBEX.** Copy of the order be sent to the parties.
