**ORDER:**

1. The RTI application is dated 18.04.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 20.05.2022 and the second appeal was filed in the Commission on 11.11.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 18.01.2023. Accordingly, the case has been heard today. Shri Suresh Kumar, appellant comes present to attend the hearing through cisco webex. He states that no information has been supplied to him so far.
3. Shri Gurpal Singh, Assistant Engineer, Municipal Corporation, Amritsar comes present to attend the hearing on behalf of the PIO through cisco webex. He states that with regard to information sought by the appellant regarding the execution of development work "Development and Reconditioning of roads (P/L B.M. and S.D.B.C.) on various roads of west Constituency", the tender was called for. However, the information as sought by the appellant is under compilation for which he prays for additional time to enable him to supply the same to the appellant.
4. The request of the respondent is acceded to. The PIO is directed to ensure that complete information is supplied to the appellant before the next hearing and also to ensure to come present in person before the Bench on the next hearing.
5. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 16.02.2023 at 11.30 AM before the Bench in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
