ORDER:

1. This order may be read with reference to the order dated 23.02.2023 passed by this Bench on the previous hearing.
2. The case has been heard today. Shri Rajan Chaudhary, appellant comes present to attend the hearing in person before the Bench and states that no information has been received by him so far.
3. Shri Maninder Singh Sidhu, Tehsildar, Abohar with Shri Kulwinder Singh Clerk O/o Tehsildar, Abohar, come present in person before the Bench to attend the hearing on behalf of the PIO. The respondent produces before the Bench reply to the show cause notice as also reply to appeal case on behalf of Respondents. He further states that a copy of the same has been handed over to the appellant today. He states that the appellant has sought information regard Khasra No.153/25/2/2(5-8) of Village Diwan Khera, Tehsil Abohar as available with Halqa Patwari and they tried to deliver information to the appellant through the Patwari but he refused to collect the same. He further states that the mutation of the property mentioned by the appellant was not sanctioned in the year 1988 and copies of all available mutations and Jamabandis have been provided to the appellant. The appellant, however, wants copy of detailed order in this regard which is not available in their official records.

4. The appellant, on perusal of the documents provided to him, expresses his dissatisfaction.

5. Post deliberations, the Bench directs the PIO to file an affidavit on e-stamp paper, within 21 (Twenty one) days, duly signed by the PIO and attested by the Notary Public to the effect that the information as available in the official records in AC No.5499/2022 has been supplied and also incorporating the position as stated by him in para 3 above regarding the mutation and the detailed order. It be further stated that nothing has been concealed therein and the information supplied is true and correct. Original affidavit be sent to the appellant and copy of the same be sent to the Commission for record.

6. With the aforesaid directions, **the instant appeal case is disposed off and closed.**
Copies of the order be sent to the concerned parties.
