- 5. The Bench now directs the PIO/Panchayat Secretary, Gram Panchayat, Kalianpur, Block Jalandhar (West), District Jalandhar to file an affidavit on e-stamp paper, within 21 (Twenty one) days, duly signed by the PIO and attested by the Notary Public to the effect that the information as available in the official
