ORDER:

- 1. The RTI application is dated 14.07.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 6.9.2022 and second appeal was filed in the Commission on 14.11.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for hearing through CISCO WEBEX on 18.4.2023 i.e. today.
- 2. In today's hearing the both the parties are present.
- 3. The appellant states that no information has been supplied to him till date.
- 4. The respondent, Sh. Rajesh Kumar states that the concerned PIO is busy in election duty, (which is assigned recently 3 to 4 days prior), so he is unable to attend today's hearing. He further requests for an adjournment.
- 5. After hearing both the parties and examining this case file, it is observed that RTI application was filed by the appellant on 14.07.2022 and notice of hearing was issued by the Commission on 20.12.2022 for today's hearing but after the ample time has elapsed, concerned PIO did not bother to supply the requisite information and failed to perform his duties as a public servant.

6. In view of the foregoing, respondent PIO, O/o EO, Nagar Council, Kartarpur is directed to

show cause in writing or through affidavit under Section 20(1) of the RTI Act, as to why

penalty be not imposed upon him for willful delay/ denial of the information to the RTI

applicant and why the compensation be not awarded to the complainant under Section 19

(8)(b) of the Act for detriment suffered.

In addition to his submission, the PIO is also hereby given an opportunity under

Section 20(1) proviso, thereto, for a personal hearing before the imposition of such penalty

on the next date of hearing. He may note that in case he does not file his submission and

does not avail himself of the opportunity of personal hearing on the next date fixed, it will

be presumed that he has nothing to say and the Commission shall proceed to take further

proceedings against him ex-parte.

7. Respondent PIO is directed to supply the point-wise information as per RTI application to the

appellant within ten days after receipt of this order under intimation to the Commission

along with directions to deal this case on priority basis.

8. Matter is adjourned for further hearing on 22.06.2023 at 11:00 A.M. through CISCO

WEBEX. Copy of the order be sent to the parties.
