ORDER:

1. The RTI application is dated 20.05.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 06.08.2022 and the second appeal was filed in the Commission on 14.11.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 23.01.2023. Accordingly, the case has been heard today. Shri Prabhkamal Singh Sahni, appellant has not come present to attend the hearing in person before the Bench or through cisco webex.
3. Shri Rajesh Kumar, Senior Assistant (Accounts), O/o GLADA, Ludhiana comes present to attend the hearing through cisco webex. He states that the information has been delivered by hand to a known Advocate of the appellant on 21.01.2023.
3. Since the appellant is absent, he is contacted on his mobile phone. He admits receipt of information, however, seeks time to go through the information and point out deficiencies, if any, in the information supplied.

Acceding to his request, the appellant is advised to point out deficiencies to the PIO to enable the PIO to supply rectified information after removal of deficiencies, if any, received from the appellant, before the next hearing and ensure to come present in person before the Bench, on the next date of hearing, otherwise the case may be decided based on documents available on file and submissions made by the respondent.

5. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 07.03.2023 at 11.30 AM before the Bench in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
