ORDER:

1. The RTI application is dated 27.08.2022 vide which the appellant has sought information as enumerated in her RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 27.09.2022 and the second appeal was filed in the Commission on 14.11.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. The notice of hearing was issued to the parties for 23.01.2023. Accordingly, the case has been heard today. Smt. Harvinder Kaur, appellant comes present to attend the hearing in person before the Bench. She states that she has sought action taken report on her applications submitted to GMADA, but no information has been received by her so far.

3. Shri Gurwinder Singh, PIO O/o GMADA, Mohali comes present to attend the hearing through cisco webex. He refers to e.mail dated 23.01.2023 sent to the Commission and states that no information has been sought by the appellant as the information sought by the appellant is in question form.

4. The Bench, on perusal of RTI application of the appellant, does not agree with the contention of the PIO and post deliberations, the PIO is directed to call the appellant on 07.02.2023 at 12.00 noon and allow the appellant access to the relevant official records and supply information as is identified by the appellant. before the next hearing. He is also directed to come present in person before the Bench on the next hearing.

5. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 07.03.2023 at 11.30 AM before the Bench in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
