**ORDER:**

1. The RTI application is dated 12.04.2021 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 14.09.2021 and the second appeal was filed in the Commission on 15.11.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 19.01.2023. Accordingly, the case has been heard today. Shri Inderdhir Singh Grewal, appellant has not come present to attend the hearing in person before the Bench or through cisco webex nor any intimation has been received from him. It has also been observed from the case file that the notice of hearing which was issued to the appellant by the Bench has been received back undelivered vide diary number 29451 dated 23.12.2022.
3. The PIO O/o GMADA, Mohali has also not come present in person before the Bench nor through cisco webex nor the PIO has deputed any of his representatives to attend the hearing on behalf of the PIO.
4. In the absence of appellant and the PIO, the Bench is unable to proceed further in the matter and deems it appropriate to adjourn the matter. The Bench, however, directs to the PIO to ensure to send the information to the appellant before the next hearing as also ensure to come present in person before the Bench on the next hearing.
