ORDER:

3. Shri Gurwinder Singh, AEO/PIO O/o GMADA, Mohali comes present to attend the hearing through cisco webex. He states that Superintendent/APIO O/o Estate Officer(H), and Superintendent/APIO O/o Divisional Engineer C-2 of GMADA have been asked to provide information to the appellant.
