**ORDER:**

1. The RTI application is dated 31.08.2021 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 11.01.2022 and the second appeal was filed in the Commission on 10.01.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The case has been heard today. As per appellant, the PIO has not supplied any information so far.
3. The respondent is absent nor is represented. The Commission has received a reply of the PIO-Non-Technical, Zona-A, MC Ludhiana dated 27.03.2023 through email stating therein that the information has already been provided to the appellant vide letter dated 24.02.2023 and a copy of the same has been sent to the Commission. Further the appellant was called in the office and he gave in writing that he has received the information and is satisfied. It has also been mentioned in the reply that the appellant had also filed similar appeal case No.6261 of 2022 for seeking exactly the same information which has been disposed off by the Bench of Shri Asit Jolly, State Information Commissioner on 09.03.2023.
4. Having gone through the record, the Commission observes that the appellant had filed appeal case No.6261 of 2022 earlier for seeking the same information which has been disposed off by Shri Asit Jolly, State Information Commissioner on 09.03.2023 whereas in a certificate filed by the appellant along with this appeal case, the appellant has undertaken that the matter under appeal or complaint has not been previously filed, pending or decided by any of the State Information Commissioner, Punjab.
5. From the above, it is clear that the information has already been provided in appeal case No.6261 of 2022, no further interference of the Commission is required. A copy of reply received from the PIO be sent to the appellant along with the order.
6. **This case is disposed off and closed.** Copies of the order be sent to the concerned parties.
