ORDER:

The appellant, through an RTI application dated 23.10.2021 has sought 5 point information i.e. copy of the action taken report on application dated 11.08.2021 and reminder dated 28.09.2021- a copy of reply of the department- copy of disciplinary action taken against the concerned officials for not preparing roaster register as per Govt. policy and other information as enumerated in the RTI application concerning the office of District Social Security Officer Ludhiana. The appellant was not provided with the information after which the appellant filed the first appeal before the first appellate authority on 25.11.2021 which took no decision on the appeal.

The case last came up for hearing on 24.08.2022 through video conferencing at DAC Hoshiarpur. The respondent Sh.Harminder Singh was present at Chandigarh and informed that the information has already been supplied to the appellant. The respondent also submitted a copy of noting relating to action taken on the application of the appellant.

As per appellant, the information was misleading and not as per the RTI application since the appellant had asked for action taken on his application dated 11.08.2021 and not on 10.04.2021.

The respondent said that they have not received the application dated 11.08.2021 of the appellant.

The PIO was directed to file an affidavit that they have not received the application of the appellant dated 11.08.2021.

Hearing dated 05.12.2022:

The case has come up for hearing today through video conferencing at DAC Hoshiarpur. The respondent has filed an affidavit as per the last order of the Commission which has been taken on record.

The affidavit is being sent to the appellant alongwith the order, and a copy of the same is retained for record.

With the above, the RTI application stands sufficiently replied to and no further interference from the Commission is required.

The case is **disposed of and closed.**
