ORDER:

1. The RTI application is dated 08.08.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 08.09.2022 and the second appeal was filed in the Commission on 15.11.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. The notice of hearing was issued to the parties for 23.01.2023. Accordingly, the case has been heard today. Shri Jasbir Singh, appellant has not come present to attend the hearing in person or through cisco webex.

3. Shri Jagpal Singh, SDO and Sh.Kanwaljeet Singh, S.D.C., Sub Division City, PSPCL, Sirhind, District Fatehgarh Sahib come present in person before the Bench. Shri Jagpal Singh, SDO produces before the Bench authority letter to represent the appeal case as also copy of information. He states that the information has been supplied to the appellant vide letter dated 27.09.2022 and again vide letter dated 22.11.2022. He further states that the appellant was called by First Appellate Authority on 17.01.2023 at Ludhiana, but the appellant did not turn up for the hearing.

4. Since the appellant is absent, attempts are made to contact him on his mobile phone. In spite of various attempts made, he does not respond to the phone calls. On the asking of the Bench, the respondent states that the information as available in the official records has been supplied to the appellant.

5. Post deliberations, the Bench directs the Notified PIO to file an affidavit on e-stamp paper, within 21(twenty one) days, duly signed by the notified PIO and attested by the Notary Public to the effect that the information as available in the official records in AC No.5581 of 2022 has been supplied to the appellant. It be further stated that nothing has been concealed and the statement made is true and correct. The original affidavit be sent to the appellant and copy of the same be sent to the Commission for record.

6. With the aforesaid directions, **the instant appeal case is disposed off and closed.**
Copies of the order be sent to the concerned parties.
