ORDER:

- 1. This order may be read with reference to the order dated 22.02.2023 passed by this Bench on the previous hearing.

The PIO has also not filed reply to the show cause notice issued on 22.02.2023 for delay in providing the information. However, in the interest of justice, one last opportunity is given and the PIO is directed to file reply to the show cause notice and appear personally on the next date of hearing otherwise the Commission will initiate action against the PIO under section 20(1) of the RTI Act.
- 4. The PIO is directed to call the appellant to his office on any working day and allow him access to the official records. After inspection of records by the appellant, the information as is identified by the appellant be provided to him before the next hearing. The PIO is directed to ensure that official

records related to RTI application of the appellant are presented for examination and documents as identified are given duly attested by the PIO. The PIO is also directed to come present in person before the Bench to attend the next hearing.

6. With the aforesaid directions, the matter is adjourned. To come up for hearing on 15.06.2023 at 11.30 AM before the Bench in Commission's Office at Chandigarh. Copies of the order be sent to the concerned parties.
