ORDER:

The appellant, through an RTI application dated 30.07.2021 has sought information on 07 points regarding details of rice—shellers, gas agencies & petrol pumps—in Jaito alongwith details of inspections conducted — details of godowns and shellers alongwith govt stock and name of inspectors under whose jurisdiction these godowns comes — details of employees working alongwith leave availed — copy of gate pass from godown to depot holders — gate passes issued on 03.06.2021 — details of godown rent and other expenses for look after of godowns etc as enumerated in the RTI application from the office of Director food Civil Supplies Pb Chandigarh. The appellant was not provided the information—after which the appellant filed a first appeal before the First Appellate Authority on 02.09.2021 which did not decide on the appeal. After filing first appeal, the PIO sent reply to the appeal in the Commission.

The case last came up for hearing on 07.06.2022 through video conferencing at DAC Faridkot. The respondent informed that the information relating to point 1 & 2 and partial information of point-3 has been provided to the appellant vide letter dated 24.09.2021. However, the salary details of employees being personal information, was not be provided. The information relating to other points were yet to be provided since the same has to be collected from the field staff.

The appellant was absent and vide email informed that the discrepancies had been pointed out to the PIO vide letter dated 28.02.2022 but the same has not yet been sorted out.

The PIO was directed to sort out the discrepancies as pointed out by the appellant vide letter dated 28.02.2022 and provide complete information to the appellant.

Hearing dated 23.11.2022 :

The case has come up for hearing today through video conferencing at DAC Faridkot. As per the respondent, the information has been provided.

As per the appellant, the information is incomplete.

Appeal Case No. 5613 of 2021

Having gone through the RTI application and hearing both parties, the following is concluded:

Point no. 1. To provide details of inspections with the date of inspection.

Point No. 3 To provide the total salary of the staff Point 4. To Provide copies of gate passes. Point 5. To provide copies of gate passes.

Point 6. To provide copies of bills pertaining to Godown rent and maintenance of

stock.

Point 7. PIO is directed to attest the information

With the above order, the case is **disposed of and closed**.
