ORDER

- 1. This order may be read with reference to the order dated 03.11.2022 passed by this Bench on the previous hearing.
- 2. The case has been heard today. Shri Milan, appellant has not come present in person or through cisco webex. However, he has sent an e-mail to the Bench dated 23.01.2023 stating that no inspection has been allowed to him and the information supplied to him is misleading.
- 3. ASI Surinderpal Singh, PS Salem Tabri, Ludhiana comes present to attend the hearing in person before the Bench and states that with regard to the information sought by the appellant, matter was enquired into and as per report submitted by the SHO, P.S. Salem Tabri, Ludhiana, it is revealed that the verification of the tenants of shops mentioned in RTI application has been got done by the concerned owners. It is also stated that a dispute between the persons Neelam etc. mentioned in RTI application is going on with her relative Varinder Sood, due to which the appellant Milan Sood has sought information regarding verification of tenants. It has been further stated that the information sought by the appellant is third party information and that the persons concerned have denied permission to share their information. The representative of PIO also produces before the Bench the documents to be handed over to the appellant.
- 4. The appellant is contacted on mobile phone to ascertain the latest position. He does not respond to the phone calls.
- 5. Post deliberations, the Bench directs the PIO O/o Police Station, Salem Tabri, Ludhiana to send a copy of the information to the appellant by registered post, with intimation to the Commission and also to send copy of postal receipt to the Commission.
- 6. After perusal of the documents produced before the Bench, the Bench observes that no further intervention in the matter is called for. **As such the instant appeal case is disposed off and closed.** Copies of the order be sent to the concerned parties.
