as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **7.10.2021** and Second Appeal was filed in the Commission on **14.12.2021** under Section 19 of the Right to Information Act, 2005. The case was last heard on **17.11.2022**.

2. As directed at the last hearing on 17.11.2022, the respondent PIO, represented at this hearing by Sh. Vaneet Kumar, SDO, B&R, Zone-D, has submitted a copy of reply sent to the appellant vide Letter No. 196 Dated 8.12.2022, by way of a pointwise reply to the RTI application.

3. The Commission has examined said reply and is of the view that this adequately addresses the RTI application. This Appeal is accordingly **Disposed of**.
