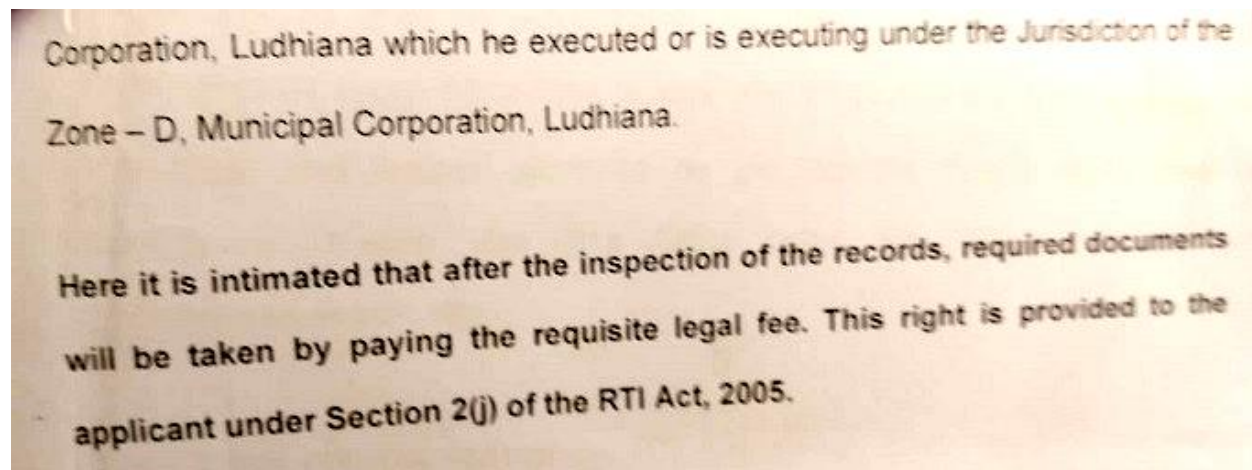

as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **7.10.2021** and Second Appeal was filed in the Commission on **14.12.2021** under Section 19 of the Right to Information Act, 2005. The case was last heard on **17.11.2022**.

2. The appellant is absent for the second successive hearing. As per a letter submitted by the respondent PIO vide Letter No. 686 Dated 30.12.2022, the appellant Sh. Rohit Sabharwal, was invited for inspection for the second time as per the Commission's Order, at 11.00 AM on 23.12.2022, but once again, the appellant failed to show up.

3. The Commission notes that the appellant has been offered two opportunities to inspect the record and has failed to do so both times. This Appeal is accordingly **Disposed of**.
