## Appeal Case No. 5663 of 2021

as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **22.9.2021** and Second Appeal was filed in the Commission on **14.12.2021** under Section 19 of the Right to Information Act, 2005. The case was last heard on **17.11.2022**.

2. The appellant is absent for the second successive hearing. The respondent PIO, represented by Sh. Vaneet Kumar, SDO, B&R, Zone-D, has submitted a reply to this Commission vide Letter No. 684 Dated 30.12.2022, wherein he states that the appellant was invited for inspection on 23.12.2022 vide Letter No.189 Dated 8.12.2022, but he did not come for the inspection. This is the second opportunity to inspect the record, as requested in his RTI application, which the appellant has failed to avail of. Earlier too, vide this Commission's Order of 2.9.2022, inspection of the relevant record was arranged on 19.9.2022.

3. In view of the above, this Appeal is accordingly **Disposed of**.
