ORDER:

1. The RTI application is dated 18.8.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 23.9.2022 and second appeal was filed in the Commission on 18.11.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. Notice of hearing was issued to the parties for hearing through CISCO WEBEX on 18.4.2023 i.e. today.
3. In today's hearing both the parties are present.
4. The appellant states that nothing has been received till date even after depositing the documentation fee amounting Rs. 300/-.
5. Respondent, Ms. Sarabdeep Kaur states that the appellant has already been informed to deposit the documentation fee on for deposit of fee on 7.10.2022, 17.2.2023 and 13.04.2023 but till date nothing has been deposited by him. She adds that a reply vide letter no. 6630 dated 10.11.2022 is also sent to the Commission, which is received in the Commission vide diary no. 26410 dated 16.11.2022 and taken on record.
6. The appellant states that he has deposited the necessary fee. The court advises him to submit the receipt through email to the respondent as well as to the Commission within ten days from today.
7. The respondent PIO is directed to supply the information within 10 days after going through the receipt of necessary fee under intimation to the Commission.
8. Both the parties are directed to represent this case in person on the next date of hearing to clear the facts of this case, failing which case will be decided on merit basis.
9. **Matter is adjourned for further hearing on 22.06.2023 at 11:00 A.M. through CISCO WEBEX.** Copy of the order be sent to the parties.
