ORDER:

1. The RTI application is dated **13.5.2022** vide which the appellant has sought information:-

R/Sir, Please provide the information under RTI Act 2005 on below points:- 1) Provide me the complete record of the colony including layout plan of colony namely Reru Extension situated at Village Reru, backside Hargobind nagar, Jalandhar 2) Please provide me full detail of fees paid by Colonizer/Promoter of colony namely Reru Extension situated at Village Reru, backside Hargobind nagar, Jalandhar 3) Please provide me the action taken report of file no. 2/MTP/Colony/Dated 01-01-2019, colony namely Reru Extension situated at Village Reru, backside Hargobind nagar, Jalandhar about 0.7937 Acre & colonizer/promoter of the colony is Smt Nirmal Kaur, S. Jaswinder Singh, S. Joginderpal, S. Baljinder Singh and S. Kamaljit Singh residing Tanda road, Jalandhar. 4) Please provide me the current status of colony namely Reru Extension situated at Village Reru, backside Hargobind nagar, Jalandhar, is this colony Legal or ill Legal. Regards

as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **27.5.2022** and Second Appeal was filed in the Commission on **14.11.2022** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on **2.2.2023**.

2. The appellant is absent without intimation. The respondent PIO, represented by Smt. Anita Rani, JA, from the office of DC, Jalandhar, states that a reply was sent online to the appellant vide Letter No. 318/RTI Branch Dated 13.5.2022, informing him that the requested information pertains to the office of Municipal Corporation Jalandhar and the same should be sought from that office.

3. As per the RTI Act, 2005, applicants must address their RTI applications to the "concerned" PIO of the "concerned" Public Authority. The appellant is accordingly advised to address his RTI application to the concerned PIO, Municipal Corporation Jalandhar.

4. This Appeal is accordingly **Disposed of**.
