ORDER:

1. The RTI application is dated 06.06.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 09.07.2022 and the second appeal was filed in the Commission on 21.11.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 01.02.2023. Accordingly, the case has been heard today. Shri Gurmej Lal, comes present to attend the hearing on behalf of the appellant through cisco webex. He states that no information has been provided to the appellant.
3. Shri Rajiv Kumar, Building Inspector, Town Planning Wing, Local Govt. Punjab comes present in person before the Bench. He states that complaint of the appellant relates to the unauthorised schools/ hospitals being run in the jurisdiction of Municipal Council, Gobindgarh and accordingly, the PIO Town Planning Wing has written to the Additional Deputy Commissioner(Urban Development),Fatehgarh Sahib and Municipal Council, Gobindgarh vide letter dated 30.06.2022 to enquire into the complaint as per Rules/Instructions and intimate the status. The appellant has also been informed in this regard vide letter dated 31.01.2023 with a copy to Hon'ble Commission by e.mail.
