**ORDER:**

1. This order may be read with reference to the order dated 01.02.2023 passed by this Bench on the previous hearing.
2. The case has been heard today. As per representative of the appellant, the appellant has not been supplied any information.
3. During last hearing, in view of statement of Shri Rajiv Kumar, Building Inspector, Town Planning Wing-Local Govt. Pb, the PIO O/o Additional Deputy Commissioner (Urban Development), Fatehgarh Sahib and PIO O/o MC Gobindgarh were impleaded as Respondent No.2 & 3 and directed to supply information to the appellant regarding the complaint dated 16.05.2022. The PIOs were also directed to come present in person before the Bench on the next hearing. Hence their presence for today's hearing.

As per respondents present from the office of MC Mandi Gobindgarh, the information/reply has been provided to the appellant vide letter dated 29.08.2022 in earlier appeal case No.508 of 2022 and appeal case No.2894 of 2022 which were filed by the appellant for seeking exactly the same information and disposed off by Shri Amrit Partap Singh Sekhon, State Information Commissioner on 29.08.2022 and 23.09.2022 respectively. The appellant agrees and states that the case may be closed.
5. Since the information has already been provided in earlier appeal cases and appellant agrees on the issue, no further interference of the Commission is required.
