ORDER:

1. This order may be read with reference to the order dated 16.01.2023 passed by this Bench on the previous hearing.
2. The case has been heard today. Gp Capt Bhupinder Singh, appellant comes present to attend the hearing in person before the Bench. He states that he has been denied information on the ground that the information sought is personal and third party information.
3. Shri Gurwinder Singh, AEO/PIO, GMADA, Mohali comes present to attend the hearing through cisco webex. The PIO states that the appellant had visited on 24.01.2023 and the information has been sent to the appellant vide letter dated 09.02.2023 along with copies of allotment letter, offer of possession and letter dated 09.05.2022 of Divisional Engineer (Buildings), GMADA and again vide letter dated 22.02.2022. Copies of the same have also been sent to the Commission by e.mail. On the asking of the Bench, the appellant denies receipt of any information.
4. After taking prints out of the information supplied, the same is shown to the appellant. He, however, on perusal of the same, expresses dis-satisfaction over documents given and says they are irrelevant.
5. Post deliberations, the Bench directs the PIO to call the appellant to his office and allow him access to the relevant official records once again. The concerned dealing officials be asked to associate with inspection of records by the appellant. The information as is identified by the appellant after inspection, be provided to him before the next hearing.

6. During the discussions, it emerges that the orders of Bench are not read thoroughly and as such, meticulous compliance of the directions of the Bench is not ensured. Resultantly, the appellants are subjected to harassment unnecessarily.

7. With the aforesaid directions and observations, the matter is adjourned. **To come up hearing on 21.03.2023 at 11.30 AM before the Bench in Commission's office at Chandigarh.**
