ORDER:

1. The RTI application is dated 31.08.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 03.10.2022 and the second appeal was filed in the Commission on 22.11.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 16.01.2023. Accordingly, the case has been heard today. Shri Bhupinder Singh, appellant comes present to attend the hearing in person before the Bench. He states that no information has been received by him so far.
3. Shri Gurwinder Singh, AEO/PIO, GMADA, Mohali comes present in person before the Bench to attend the hearing through cisco webex. The PIO states that RTI application of appellant is not available with him. The Bench reads out the issues raised by the appellant in his RTI application to the PIO. The PIO requests for details of flat number and project regarding which information has been sought. The PIO assures to provide the information before the next hearing.
4. Post deliberations, the Bench directs the PIO to call the appellant to his office on 24.01.2023 at 11.30 AM and allow him access to the relevant official records. The information as is identified by the appellant after inspection, be provided to him before the next hearing.
5. With the aforesaid directions, the matter is adjourned. **To come up hearing on 22.02.2023 at 11.30 AM before the Bench in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
