ORDER:

1. This order may be read with reference to the order dated 16.01.2023 passed by this Bench during the previous hearing.
2. The case has been heard today. Shri Sanjeev Kumar, appellant comes present to attend the hearing in person before the Bench.
3. Shri Jasjit Singh, Assistant Engineer, Sub Division, PSPCL, Sudhar, District Ludhiana comes resent in person before the Bench to attend the hearing on behalf of the PIO and states that out of 13 points, information was supplied vide letter dated 29.09.2022 and again balance information was given on 11.01.2023 and information on point No.11 & 13 was left which is being handed over to the appellant today.
4. The appellant admits receipt of information on all points. He, however, states that the information supplied on point No.4 & 5 is not satisfactory and also refers to his observations submitted to the Bench vide letter dated 17.02.2023. The respondent explains to him the position regarding information on point No.4 & 5 as per letter dated 11.01.2023. However, the appellant is still not satisfied with the explanation given by the respondent.

5. Post deliberations, the Bench directs the notified PIO to file an affidavit on e-stamp paper, within 21 (Twenty one) days, duly signed by the PIO and attested by the Notary Public to the effect that the information as available in the official records in AC No.5805 of 2022 has been supplied to the appellant. Regarding information on Point No.4 & 5, it be clarified that the official against whom enquiry was sought, was called verbally to associate with the enquiry and during enquiry, his submissions were verbally heard and not recorded. It be further stated that nothing has been concealed therein and the statement made is true and correct. Original affidavit be sent to the appellant and copy of the same be sent to the Commission for record.

6. With the aforesaid directions, **the instant appeal case is disposed off and closed.**
