**ORDER:**

1. This order may be read with reference to the order dated 22.02.2023 passed by this Bench on the previous hearing.
2. The case has been heard today. Shri Balwinder Singh, appellant comes present in person before the Bench and states that he has not been provided any information till date.
3. As per respondent present from the office of RTA Ferozepur, the information has been sent to the appellant vide letter dated 18.04.2023 through registered post. The respondent has also brought a copy of information for handing over the same to the appellant during the hearing itself. However, due to sudden deterioration in health of the appellant due to fluctuation in blood pressure, the appellant was shifted to hospital for treatment and the information could not be handed over to him. The respondent also submits a copy of information in the Commission which is taken on record.
4. The PIO is directed to send the information again to the appellant through registered post. The appellant is directed to point out the discrepancies if any to the PIO and the PIO is directed to resolve the same before the next hearing.

5. The PIO is also directed to file reply to the show cause notice issued on 22.02.2023 for not providing the information as well as not appearing before the commission despite repeated notices/orders.

8. With the aforesaid directions, the matter is adjourned. **To come up hearing on 19.06.2023 at 11.30 AM before the Bench in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
