ORDER:

1. The RTI application is dated 01.09.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 03.10.2022 and the second appeal was filed in the Commission on 24.11.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. The notice of hearing was issued to the parties for 01.02.2023. Accordingly, the case has been heard today. Shri Harjot Singh Bedi comes present to attend the hearing in person before the Bench on behalf of the appellant and produces before the Bench Vakalatnama to represent the appellant. He states that no information has been received by the appellant so far.

3. Neither the PIO, PUDA, Mohali has come present to attend the hearing in person before the Bench nor through cisco webex.

4. The perusal of the case file shows that the area regarding which information has been sought falls within the jurisdiction of GLADA, Ludhiana. As such, the PIO O/o GLADA, Ludhiana is impleaded as Respondent No.2. He is directed to supply point-wise information to the appellant before the next hearing and also ensure to come present to attend the hearing in person before the Bench on the next hearing. The PIO O/o PUDA is also directed to come present in person before the Bench on the next hearing.
