ORDER:

1. The RTI application is dated 01.09.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 08.10.2022 and the second appeal was filed in the Commission on 24.11.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and the hearing has been fixed for today.
2. In today's hearing, the appellant states that incomplete information has been supplied to him.
3. Sh. Sanjiv Kumar, Senior Assistant states that the information relates with the office of PIO O/o Technical Education and Industrial Training Department, (Technical Education -1 Branch), Punjab Civil Secretariat -2, Sector 9, Chandigarh. He adds that reply was also sent to the appellant via letter number 1/541507/2023 dated 11.04.2023 with a copy to the Commission via email dated 11.04.2023, which is received by the undersigned Bench and taken on record.
4. After hearing both the parties and examining the case file, respondent PIO, O/o Technical Education and Industrial Training Department, (Technical Education -1 Branch), Punjab Civil Secretariat -2, Sector 9, Chandigarh is impleaded as a necessary party in this case. A copy of this order be sent to the respondent PIO along with RTI application for his ready reference.
5. Both the PIOs from O/o Director, Technical Education & Industrial Training Department, Punjab, Chandigarh and O/o Technical Education and Industrial Training Department, (Technical Education -1 Branch), Punjab Civil Secretariat -2, Sector 9, Chandigarh are directed to mutually cooperate and supply the information to the appellant within ten days after receipt of this order along with directions to appear in person on the next date of hearing to clear the facts of this case.
