ORDER:

1. The RTI application is dated 26.10.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 01.11.2022 and the second appeal was filed in the Commission on 25.11.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 01.02.2023. Accordingly, the case has been heard today. Shri Vinod Kumar Singh, appellant comes present to attend the hearing in person before the Bench and states that partial information has been supplied to him.
3. Neither the PIO, PUDA, Mohali has come present to attend the hearing in person before the Bench nor through cisco webex.
4. The perusal of the case file shows that a letter dated 22.11.2022 written by Chief Town Planner, O/o Director, Town & Country Planning, Punjab to the appellant is available whereby the appellant has been informed that approval regarding CLU in respect of the land areas of M/s Ambika Realcon Builders

Pvt. Ltd., Sector-66, S.A.S. Nagar have been issued. The same has also been intimated by the PIO O/o Chief Town Planner, Punjab to the Administrative Officer/PIO, PUDA, Mohali vide letter dated 25.01.2023 enclosing there with a copy of the information supplied..

5. Shri Gurwinder Singh, AEO/PIO, O/o GMADA, Mohali is contacted on his mobile phone. He states that the PIO/Chief Town Planner O/o Director, Town & Country Planning, Punjab and the Superintendent/APIO, Building Branch, GMADA, Mohali have been directed to provide information to the appellant.

The Bench directs the Superintendent/APIO, Building Branch, GMADA, Mohali and PIO/Chief Town Planner O/o Director, Town & Country Planning, Punjab, Mohali to supply information to the appellant on the points relating to their offices and ensure to come present in person before the Bench to attend the hearing on the next date, along with the relevant records.

7. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 03.04.2023 at 11.30 AM before the Bench in Commission's Office at Chandigarh.** Copies of the order be sent to the concerned parties.
