**ORDER:**

1. The RTI application is dated 30.06.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 22.08.2022 and the second appeal was filed in the Commission on 17.11.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and the hearing has been fixed for today.
2. In today's hearing, the appellant, Sh. Sarabjit Singh states that the information in connection with point number 18 is received only and rest of the information relates with point number 1 to 17 of the RTI application is still pending. He submits a letter dated 10.04.2023 regarding discrepancy in the supplied information in connection with point no. 1 to 17 during the hearing, which is taken on record.
3. On the other hand, Sh. Balbir Singh states that the information has already been supplied and further assures that the deficiencies will be removed timely.
4. After hearing both the parties and examining the case file, a copy of discrepancy letter dated 10.04.2023 submitted by the appellant, copy of RTI application be sent to the respondent PIO along with this order for his ready reference. Respondent PIO is directed to remove discrepancy as per RTI application from point no. 1 to 17 only within fifteen days after receipt of this order under intimation to the Commission.
5. Both the parties are advised to represent this case in person on the next date of hearing, failing to which, appropriate order in their absence shall be passed.
6. This case is adjourned and both the parties are directed to come up on **18.07.2023 at 11:00 A.M. through CISCO-Webex**. Copy of the order be sent to the parties.
