ORDER:

1. The RTI application is dated 05.09.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 07.11.2022 and the second appeal was filed in the Commission on 11.01.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. The case has been heard today. The appellant comes present to attend the hearing in person and states that no information has been given to him by the respondents yet.

3. Shri Amandeep Singh, Sr. Assistant O/o SSP, Patiala along with ASI Harpal Singh O/o Police Station, Tripri comes present on behalf of the PIO and state that they have brought the information for the hearing to be handed over to the appellant during the hearing itself. Copy of the same is handed over to the appellant for his perusal. After going through the documents, the appellant states that partial information has been given and information especially on point nos. 7,10,11,12 & 13 is not complete and is being avoided.

4. Both the respondents state that complete information as per official records has been given and nothing beyond what has been given is available in official records.

5. In view of the aforesaid discussion and examining the documents brought along by the respondents, the Bench directs the notified PIO o/o SSP, Patiala and SHO, Police Station, Tripri to file an affidavit separately on e-stamp paper within twenty one days (21 days) duly signed by the PIO and attested by the Notary Public to the effect that the information as available in the official records in AC No.590 of 2023 has been provided to the appellant. It be further stated that nothing has been concealed therein and the statement made is true and correct. Original affidavit be sent to the appellant and copy of the same be sent to the Commission for record.

6. With the aforesaid directions, **the instant appeal case is disposed off and closed.** Copies of the order be sent to the concerned parties.
