The PIO O/o JDA, Jalandhar, PIO O/o DTP, Jalandhar and appellant all are directed to come present in person before the Bench.
- 6. With the aforesaid directions, the matter is adjourned. To come up for hearing on 06.06.2023 at 11.30 AM before the Bench in Commission's Office at Chandigarh. Copies of the order be sent to the concerned parties.
