**ORDER**

1. The application dated 18.7.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 5.9.2022 and second appeal was filed in the Commission on 29.11.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for hearing for 27.4.2023 through CISCO WEBEX application.
2. The hearing for 27.4.2023 was postponed to 7.6.2023 as a mark of respect the Punjab Government declared 27.4.2023 a holiday on the sad demise of Sh. Parkash Singh Badal, Ex-CM, Punjab.

4. The appellant states that he has sought information but the same is still awaited. He further states that he has been told that the matter is under investigation and unable to provide the sought for information.
5. Respondent, Sh. Sher Singh states that reply was sent to the appellant on 05.06.2023 with a copy to the Commission via email dated 05.06.2023 stating therein that matter is under consideration by the Government, which is received by the undersigned Bench and taken on record. He adds that appellant demanded similar information in another case (i.e. Appeal Case No. 5417 of 2022), which is fixed for 20.06.2023 by the undersigned Bench.
6. Both the parties are advised to represent this case in person on the next date of hearing, failing to which, appropriate order in their absence shall be passed.
